Additional Information

- On account opening the account holder must nominate a My Community Partner from the list of eligible partners supplied.
- For every \$1 of interest earned by the account holder, BDCU Limited will pay a grant equal to a percentage (%) of the interest earned by the account holder to the nominated My Community Partner.
- Payments will be paid to the nominated My Community Partner in February and August each year.
- Account holders may change their My Community Partner nomination at any time by advising staff in any of our Branches or by calling 02 4860 4000 during normal business hours.
- The last nomination in place will be eligible to receive the grant from BDCU Limited, at the next payment due date e.g. if the nomination is changed on 28th June the grant will be paid to the new nominated My Community Partner for the preceding period.
- BDCU Limited, in consultation with members and other interested parties, will determine, from time to time, the charities, community groups, schools, school affiliated groups and other organisations to be included as eligible My Community Partners.
- Addition to, or removal from the eligible listing and any changes to the grant percentage rate is at the discretion of BDCU Limited.
